# NZOIA Chair Annual Report - 2017/2018

It has been another busy year for the NZOIA Board, staff, contractors and assessors. The key activities and achievements for the 2017/18 year have included:

- The ongoing core business of running assessments, revalidations and training courses with increases in membership (1243, 13% growth) and training/refresher workshop attendance (380, 3.5% growth), and qualifications awarded at a similar level to last year (381, 1% drop)
- Finalising new mountain bike, artificial whitewater and multisport kayak and Canyon Leader qualifications
- Six organisations/businesses joined as Affiliated Members potential to put 50-60 staff through NZOIA Leader assessments
- Profiling NZOIA and NZOIA qualifications in the adventure tourism industry four of the Affiliated members are in this sector
- Another very successful Symposium hosted by NMIT and Rotoiti Lodge Outdoor Education Centre
- Reduced administrative work in membership renewals with the simplified NZOIA membership fees model introduced last year.
- Continued work with Skills Active on alignment of NZOIA and NZ Certificate qualifications, including joint development of the new mountain bike qualifications.
- Review of the NZOIA Strategic Plan.

Review of the Strategic Plan and NZOIA–NZ Certificate alignment have been key priorities for the Board.

Prior to the 2017 Symposium and AGM, the Board circulated a strategy discussion document. We identified 3 key questions/areas of focus - revenue and funding model, membership services, and alignment with NZ Certificate qualifications. Taking account of feedback we received, in particular at an open session with Board members at the Symposium, we confirmed key priorities for the 2017/18 year. These included continued profiling NZOIA in the adventure tourism sector and in areas of New Zealand where there is a low NZOIA presence/awareness, building more member benefits and growing NZOIA membership, and working through the detail of NZOIA/NZ Certificate alignment with Skills Active. At the same time we have been reviewing the NZOIA Strategic Plan.

There will be opportunity to discuss a new draft Strategic Plan with Board members at the Symposium. The Board's view is that NZOIA should continue *to support the New Zealand outdoor sector and its professional members by providing the benchmark for good practice in outdoor leadership*. The development of the Outdoor Recreation qualification strands under the Skills Active umbrella has created challenges and opportunities for NZOIA. It is exciting to work together this year to develop the joint mountain biking qualifications, providing the opportunity for mountain bike instructors/guides to benefit from the NZOIA awards and membership as well as gain NZ Certificate accreditation. This is a learning process in itself for both NZOIA and Skills Active and has had its challenging moments for both organisations. The next step is to apply these learnings and opportunities across other outdoor activities/qualifications.

The success of NZOIA depends on our operations/office team of Penny Holland, Sonya Sutherland, Pip Russell and Steff Willmore. Thank you to them, and to Dave Mangnall who has been helping out on the development of new qualifications and Quarterly editor Jen Riley for their dedicated and effective work. Thanks also to the NZ Recreation Association for their support through Deb Hurdle and CE Andrew Leslie. Surveys following the NZOIA Symposium, and assessment, refresher and training events, gave scores of 100% and 99% satisfaction respectively, and the membership survey carried out earlier this year showed 94% satisfaction with the support provided by NZOIA staff.

After three consecutive years of financial surplus from 2013/14 to 2015/16, amounting to \$90,373, the Board has budgeted for deficits in the last two years to enable work on several one-off projects, in particular developing mountain bike, artificial whitewater and kayak multisport qualifications, and putting significant effort into growing the NZOIA membership including implementing the Affiliated membership model, as well as the alignment work with Skills Active. This is reflected, as shown in the expenditure graph below, in increased staffing and other costs compared to the previous three years.

The final year end result was a deficit after projects of \$25.5k, with an operating surplus of \$12.5k before project expenditure of \$38k.

NZOIA's revenue comes almost evenly from membership fees, course/assessment and Symposium income, and grants. The grants income has dropped in the last two years. In particular this reflects the move by Water Safety NZ away from supporting skill development, as offered by NZOIA, to drowning prevention. A simplified membership fee model of \$200 for full members with NZOIA level 1 and level 2 qualifications was introduced this year. This is the same membership fee as members paid in 2000. The Board is this year putting a proposal for a fee increase to the AGM.





At the end of the 2017/18 financial year NZOIA had cash reserves of \$334,807 and net current assets of \$130,053. The cash reserves are about 80% of our annual operating costs, which puts NZOIA in a strong position considering the organisation's reliance on year by year grant income to supplement membership and assessment/course income. The Board policy is that NZOIA should hold cash reserves of at least 50% of its annual expenditure.

The Board would like to acknowledge the financial support received from SportNZ, the New Zealand Community Trust and Skills Active in 2017/18. The support of these organisations makes a significant contribution to the provision of an affordable, high standard qualification system for outdoor professionals, and hence to safe enjoyment of the outdoors by thousands of New Zealanders.

Thank you to the Board members – Ben Corcoran, Jo Thompson, Matt Barker, Cam Walker, Noel Saxon and Travis Donoghue, TSC Convenor Tim Wills and Accountant Angela Mangnall, all of whom put in time and energy to keep NZOIA on track. Thank you also to the assessors and others of you who put time into the NZOIA qualifications system. A large part of NZOIA's value and integrity is because it is an organisation developed and run by people working in the outdoor sector, for the sector.

# Tēnā koutou

From a management perspective 2017/2018 has been another big year where staff are stretched to meet the needs of members and partners and the demands of funders all within a tight budget and with a very small team. I would like to acknowledge the on-going efforts of Sonya Sutherland, Penny Holland, Pip Russell and Steff Willmore who work tirelessly but cheerfully to achieve all these things. It was pleasing to see that their efforts didn't go unnoticed in the membership survey, with 94% satisfaction with NZOIA services. While the team were pleased by the show of support they are certainly not sitting back on their laurels and are looking for ways to make 2018/2019 even better.

As far as the membership survey goes we have taken your feedback on board and are working through a checklist to respond to some of the points raised. The most significant of these is a review of revalidation and the issue of course accessibility. Other things that we continue to work on are quality of resources, communication and benefits for members.

# Our members

We ended the financial year with 1243 members, a 13% increase from 2016/2017 and six affiliated members – Ultimate Hikes, Wero Whitewater Park, Kristen College, Adventure Group, Expedition Group, Lake District Adventures Ltd. Across them they employ around 60 staff who will be working towards securing NZOIA leader qualifications in the near future. This can only be good for the profession and domestic and international users of our instructors and guides. It is great to see so many organisations recognising the value of their staff holding NZOIA qualifications.

# What we have achieved

This last year saw 381 NZOIA qualifications gained by leaders, instructors and guides across the country, three down on the 2016/2017 figure; 380 people attended training and refresher workshops, 13 more than in 2016/2017 and 156 attended the Symposium at St Arnaud, up 15 from 2016/17. Satisfaction levels for Symposium, training and refresher workshop and assessment events remain high at 100% and 99.3% respectively.

As well as delivering all those qualifications, refreshers and training, four new qualifications were introduced – Artificial Whitewater, Multisport Kayak/Endorsement, Mountain Bike and Canyon Leader.

Mountain Bike was the first opportunity for NZOIA to work jointly with Skills Active to develop the qualification and run a joint assessor workshop. While only two of the initial assessors were NZOIA members another six of them have now become members. This is already looking to be a very popular qualification so we look forward to many more members signing up for it in the future.

# Finances

The end of the 2016/2017 financial year was the end of year one of the current funding arrangement with Sport NZ and continues to rely heavily on that funding to support its operations. This is something the staff and Board are very aware of and are continuing to look for ways to diversify income streams. Clearly one of those is membership fees and with some \$30,000 of unpaid membership fees at the end of the financial year this places pressure on the staff to follow up and

the financial viability of the organisation. The staff are happy to find solutions for members whose fees are outstanding.

The overall deficit for the year taking into account project work was -\$25,451, which was less than the -\$50,000 the Board originally budgeted for. Before deducting the cost of the very necessary project work we actually made an operating surplus of \$12,392. Again we have the diligence of the staff, particularly Sonya Sutherland for their efforts to keep any deficit as low as can be at the same time maintaining the same level of service that members and partners expect.

# Working towards an aligned qualification system

NZOIA continues to work with Skills Active through the review of qualifications (TRoQ) process and is working more closely with Skills Active to deliver an aligned qualification system that will see NZOIA members being able to secure NZ Certificates as each of the new ones are up and running. This has not been an easy exercise and continues to take a lot of the Board and Penny Holland's time but the staff are supportive that this is a priority for the organisation.

# Advocacy

With the New Zealand Recreation Association's (NZRA) increasingly effective role in the advocacy space NZOIA has been able to focus more on conveying the advocacy issues raised by members to NZRA and supporting them in their approach. This has freed up some time for the staff to focus on the administration of qualification development and delivery, training and assessment.

# The future

With two year remaining of the current Sport NZ funding we will continue to look at new ways to work towards financial sustainability for the organisation. We will continue to strengthen the many partnerships we have and increase benefits for our members at the same time maintaining the quality of service and resources that we deliver to the membership.

### **Entity Structure**

A Chair is chosen by the Board from its seven directors. The term for a director is three years. The Board may also co-opt members. The Board establishes a technical advisory committee to advise on standards and syllabus.

NZOIA's staff consist of three full time (0.8) staff (Assessment and Membership Coordinator, Operations Manager and Business Manager), and one part-time administration staff member. The New Zealand Recreation Association (NZRA) provides Executive Services to NZOIA.

NZOIA contracts assessors to deliver training, revalidation and assessment workshops, and to carry out project work.

# **Statement of Accounting Policies**

# New Zealand Outdoor Instructors Association For the year ended 30 June 2018

## **Basis of Preparation**

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

## Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

### Income Tax

New Zealand Outdoor Instructor's Association is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

#### **Bank Accounts and Cash**

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

#### **Changes in Accounting Policies**

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.
